1. Type approval for electric motors is to be maintained separately from this approval.
2. This certificate is valid on condition that an annual surveillance audit for the Quality Assurance System is carried out and found to be satisfactory by the Society.
3. Test and Survey for each electric motor are to be carried out by the manufacturer in accordance with the requirements of the Society's Rules for Classification of Steel Ships and approved manufacturer's Quality Assurance Procedure.
4. The Product Certificate issued by the manufacturer is to be forwarded to the KR Copenhagen Office together with the manufacturer's test records and material certificate of shaft for motors of 100 kW and above for endorsement thereon by the Surveyor.
5. The Confirmation Survey is to be carried out by the Surveyor of KR Copenhagen office at least once a year.
6. Each certified electric motor is to be marked with  HEL04300 + Serial No. by the person in charge of Manufacturing Survey.
7. The special steel stamp  supplied by the Society is to be kept by the person in charge of Manufacturing Survey.
8. In case where other organizations especially request witnessing of the test by the Surveyor or there is any problem with the quality of certified products, the Society may directly issue, with prior notice, the product certificate upon witnessing of the tests regardless of aforestated survey delegation.
9. All customer complaints to products certified under this Quality Assurance System shall be reported to this Society.
10. The following documents are to be prepared by the manufacturer and made available at the request of the Surveyor ;
 - Material test reports for shaft
 - Inspection reports for shop trial, overhaul and etc.
 - Documents and data for Quality Control Activity
